The Council will undertake the Decriminalisation of On-Street Parking in the district boundaries of Wyre Forest, Worcestershire.</b></li><li><b>2. The Council adopts the Parking Charge Notice level of £60.00 per parking offence, discounted to £30.00 for payments received within 14 days and incremented to £90.00 for payments after the issue of a charge certificate, as reflected in the financial model and consultant report.</b></li></ol>	To be appointed

	<p><b>3. *The Council appoint an elected member and substitute elected member, to be its representative on The National Parking Adjudication Service Joint Committee, the Councillor to be appointed to be agreed at a later date by the Council.</b></p> <p><b>4.
