FOOTPATH RK-631 (PART), FORMERLY FOOTPATH 141, IN THE PARISH OF ROCK
PUBLIC PATH DIVERSION ORDER 2008

The above Order, made on 14 August 2008 under Section 119 of the Highways Act 1960, will divert the entire length and width of footpath RK-631 (part) in the parish of Rock, commencing at Ordnance Survey Grid Reference (OSGR) SO 7687 6949, the path proceeds in a generally south south westerly direction, across an earth surface, through a dwelling and across a tarmac track for approximately 45 metres. The path then continues in a generally south south westerly direction across a residential garden, through a dwelling and across a grassed area, for approximately 45 metres, to cross a boundary and terminate at its junction with Netherton Road (2071) at OSGR SO 7688 6941. The total distance of the footpath is approximately 50 metres.
To a line commencing at Ordnance Survey Grid Reference (OSGR) SO 7687 6949 (point A on the Order map). The footpath proceeds, at a width of 3 metres, in a generally easterly direction across an earth surface adjacent to a fence boundary, for approximately 6 metres, before turning onto a generally south south easterly heading, to continue adjacent to the fence boundary on an earth and earth and vegetation surface, for approximately 45 metres. The footpath continues in a generally south south easterly direction, adjacent to a brick wall boundary, for approximately 30 metres, before curving onto a generally south westerly heading to continue across a grassy surface, for approximately 20 metres, to terminate at its junction with Netherton Road (2071) at OSGR SO 7688 6940. The total distance of the footpath is approximately 100 metres.
