

## Appendix 1

### Wyre Forest District Core Strategy Preferred Options Consultation Summary

Following the Council's approval of the Preferred Options Paper in November 2008 the following documents were produced:

- Core Strategy Preferred Options Paper
- Core Strategy Draft Sustainability Appraisal Report
- A4 leaflet promoting the Core Strategy Preferred Options and its consultation
- General Comments Form

#### **Consultation:**

The consultation period for the Preferred Options Paper ran from 15<sup>th</sup> January until 13<sup>th</sup> March 2009. During this time the consultation was promoted in the following ways:

- **Letters**

In January 2009, a total of 584 letters or emails were sent out to Statutory Consultees, Hard to Reach Groups and various organisations and individuals who had expressed an interest in the Local Development Framework.

- **Exhibitions**

During January and February 2009, the Forward Planning Section manned a series of exhibitions across the District. This gave consultees and members of the public the opportunity to learn more about the Core Strategy preferred Options and to discuss the consultation paper with officers. Documents were made available to view and to loan. The table below sets out attendance figures for the exhibitions.

### Wyre Forest District Core Strategy Preferred Options Consultation Summary

- **Website**

All documents, leaflets and comment forms were made available to view or download on the District Council's web-site via the Limehouse consultation portal. Respondents were also able to make electronic responses online via Limehouse.

- **Posters**

Posters were distributed for display to all of the Post Offices in the District. The posters highlighted the consultation event and the times and locations of the exhibitions.

- **Leaflets**

During January 2009 a leaflet promoting the Core Strategy Preferred Options and its consultation was distributed to households in the District by way of an insert in the Kidderminster Shuttle. The leaflets were distributed as follows:

- 33,338 leaflets dispatched with the free Kidderminster Shuttle
- 10,420 leaflets sent to householders within the District that do not receive the Kidderminster Shuttle
- 4300 leaflets inserted into retail copies of the Kidderminster Shuttle and Times

- **Presentations**

The Forward Planning Section offered to give presentations to the District's Parish and Town Councils. In February and March 2009 presentations were given to Bewdley Town Council, Chaddesley Corbett Parish Council and the Bromsgrove and Wyre Forest Branch of the Campaign to Protection of Rural England.

#### **Response Summary:**

The District Council has received responses from 78 Respondents, including key stakeholders such as the Environment Agency, Natural England, English Heritage, Government Office West Midlands (GOWM), West Midlands Regional Assembly (WMRA) and many from local residents.

Of the 78 Respondents, 34% chose to respond by letter, 45% by email and 21% responded online.

These respondents have generated 533 comments. Analysis of these comments is as follows:
