Kidderminster Crown Post Office branch, Crown House, Bull Ring, Kidderminster – Proposed move to new premises and branch modernisation

# 1. PURPOSE

1.1 To seek approval from the Leader of the Council to submit representations to the Post Office regarding their proposed relocation of the central Kidderminster branch, currently located in Crown House, to premises within the WHSmith store in Vicar Street.

## 2. RECOMMENDATION

2.1 To agree that the comments attached at Appendix 1 to this report be submitted to the Post Office as part of their consultation process on proposed relocation of the Crown House unit to WHSmith in Kidderminster.

# 3. BACKGROUND

- 3.1 The Post Office is proposing to relocate their current premises in Kidderminster town centre and share premises with WHSmith High St Ltd. The move is part of their programme to transform and modernise the Post Office network to help create a network of branches that are modern, sustainable, profitable and no longer reliant on Government funding.
- 3.2 The branch is currently one of the 369 which are directly owned by Post Office Limited. A far greater number (approx 10,000) are successfully run by third parties within retail premises.
- 3.3 The Post Office believe that the best approach to retaining the branch in Kidderminster town centre is to change the way it operates so that if the move goes ahead the branch will be run by WHSmith High Street Limited.
- 3.4 The consultation process began on 14<sup>th</sup> October 2013 and closes on 25<sup>th</sup> November 2013. If the proposals contained in the consultation are approved then the relocation would occur in February 2014 and the Post Office would be run by WHSmith High Street Limited.

# 4. KEY ISSUES

- 4.1 The key elements of the proposals are as follows:
  - Relocation of premises from Crown House to WHSmith on Vicar Street;
  - Change of management of the branch from Post Office to WHSmith
  - Longer opening hours;
  - A reduction in serving positions to a total of five. This number has been based by the Post Office on current and future predicted business levels;
  - The proposed new location is only 110 metres from the current unit and access is along level terrain; and
  - Access to the unit is fairly similar in nature, due to the central location of the store.
- 4.2 The relocation will ensure the continued presence of the Post Office within the centre of Kidderminster. It is considered that there is good synergy with the selected partner for the

- proposal as WHSmith already successfully runs over 80 Post Office branches nationwide. Local examples of this include the Post Office in Worcester City Centre.
- 4.3 The consultation letter from the Post Office makes clear that the decision to change the way the Post Office operates the branch is not for public consultation and therefore the focus should be on the appropriateness, or otherwise, of the proposed new store.
- 4.4 It is also important to note that the plans outlined in this consultation will mean that, subject to approval, the premises at Crown House will be vacated in February 2014. This proposal has clear synergy with the Council's plans to demolish Crown House and will enable this process to be undertaken sooner rather than later. If the Post Office were to remain in situ in Crown House then it is likely this would delay the proposals to regenerate this part of the town, as envisaged by the Public Realm work that has recently been undertaken by the Council.
- 4.5 Given that the proposals would help the Council realise the plans for regeneration at the Bull Ring, coupled with the fact that the proposals would ensure that the Post Office retained a central presence in the District's main town in a modernised branch, it is considered that the proposed relocation should be fully supported.

# 5. FINANCIAL IMPLICATIONS

5.1 There are no financial implications to the Council as a result of this report.

# 6. LEGAL AND POLICY IMPLICATIONS

6.1 There are no legal or policy implications for the Council as a result of this report.

# 7. RISK MANAGEMENT

7.1 The continued presence of a centrally located Post Office in Kidderminster town centre is fully supported. There is a risk that by not supporting the proposals the Post Office will close operations temporarily until an alternative is found. Alternatively, there is a risk that by not supporting the proposals they may take the decision to close this particular branch permanently.

# 8. EQUALITY IMPACT ASSESSMENT

8.1 The Post Office will have undertaken an Equality Impact Assessment of their proposals.

# 9. **CONCLUSION**

9.1 The plans outlined in this consultation are fully supported. The proposals will ensure that the Post Office retains a central presence within the main town in the District and will also allow for the demolition of Crown House to be undertaken in a timely fashion.

## Appendix 1

# Kidderminster Crown Post Office Branch – Proposed move to new premises and branch modernisation

### **General Comments:**

Wyre Forest District Council fully supports the plans to relocate and modernised the central Kidderminster Post Office branch to WHSmith on Vicar Street. The proposed new unit is centrally located within the town and only 110 metres away from the current branch. The proposed relocation will ensure that the Post Office retains a central presence in the Districts largest town. Furthermore, the proposals help to ensure that the Council's plans for the regeneration of the Bullring area of the town will be able to continue without undue delay.

# Response to specific consultation questions:

# How suitable you think the new location and premises are and how easy it is to get there?

The District Council believe that the proposed new location and premises are suitable to meet the needs of residents wanting to access the Post Office services. The proposed location is still within the centre of Kidderminster which means that there are a number of transport options available to residents to access the services.

# Are the new premises easy for you to get into and is the inside easily accessible?

As an already established retail unit within the town it is considered that the proposed new location is easy to access.

# Do you have any concerns about the new location or premises? (If so, do you have any suggestions that could help us make it better for you?)

The only concern raised by the District Council in relation to the new premises is the proposed reduction in serving positions that will be available. This could cause longer delays for people accessing the service and cause congestion within the existing store. One way this could be resolved is to provide more than the scheduled five serving positions.

# Any local community issues which you think could be affected by the proposed move?

No comment.

# Anything you particularly like about the proposed change?

The proposed relocation will tie in with wider regeneration plans for the Bullring area, where the current facility is located. This proposed relocation will therefore provide a dual benefit of retaining the Post Office presence within the town centre, whilst allowing redevelopment plans at the Bullring to be undertaken in a timely manner.
