## **APPOINTMENT OF MEMBER TO KIDDERMINSTER AND DISTRICT YOUTH TRUST**

### **1 PURPOSE OF REPORT**

1.1 To appoint a Councillor to fill a vacancy that has arisen in respect of the Trust.

### **2 RECOMMENDATION**

2.1 That the Leader **AGREES** to appoint Councillor Jeff Baker as one of the Council's representatives on the Kidderminster and District Youth Trust for the remainder of the municipal year 2015/16.

### **3 BACKGROUND**

3.1 On 27 May Council appointed its four representatives on the Trust for the municipal year 2015/16. Following the resignation of Councillor Ruth Gregory last month, there is a vacancy to be filled.
