# **APPOINTMENTS TO EXTERNAL BODIES**

### **PURPOSE OF REPORT**

1.1 To appoint a Councillor in respect of two vacancies that have arisen.

### **RECOMMENDATIONS**

  - a) Councillor Ken Henderson instead of Councillor Tracey Onslow as the community member for Wyre Forest Community Housing for one year with effect from September 2016;
  - b) Councillor Juliet Smith instead of Councillor Tracey Onslow as a member of Wyre Forest Citizens' Advice Bureau Management Committee for the remainder of the municipal year 2016/17.

### **BACKGROUND**

- 3.1 Among the appointments to external bodies made by Council on 25 May 2016 was the appointment of Councillor Tracey Onslow as community member for Wyre Forest Community Housing for one year. While the appointments to the various positions within Community Housing Group are dealt with at the Council's annual general meeting, in practice the appointments take effect from September and thus members appointed at the AGM have not yet taken up their roles. In addition, Councillor Onslow was re-appointed for a year to the Wyre Forest Citizens' Advice Bureau Management Committee.
- 3.2 Councillor Onslow has indicated that she is no longer able to take up, or continue with, these positions because of her other commitments. In accordance with the Council's constitution the in-year vacancies therefore fall to the Cabinet to fill.

### **KEY ISSUES**

4.1 The vacancy in respect of the Community Housing Group needs to be filled to ensure that the Council takes up all the positions. Councillor Ken Henderson

has expressed an interest in being appointed to the role instead, and comes from the same political group.

4.2 Councillor Juliet Smith has expressed an interest in being appointed to the Citizens" Advice Bureau, and comes from the same political group.
